Warranties:

Limited Parts Warranty: Seller warrants to the Original Purchaser any part it sells to be free from defect for a minimum of 90 days. If the part falls in normal use or service. Seller will repair the part, furnish a replacement part, or will refund the purchase price of the part at Seller's option, subject to the conditions listed below.

This warranty is subject to the following conditions:

- 1) Unless otherwise stated on this invoice, warranty expires 90 days after the date of purchase. Requests for warranty coverage must be made prior to the expiration of the warranty. Claims made after this time will not be covered under warranty.
- 2) Defective transmissions, axie assemblies, and engine assemblies must be made available to the seller installed in the vehicle for the purpose of analysis before warranty coverage will be considered.
- 3) New fluids, filters, seals, and gaskets must be used when installing the part. Engine oil and transmission fluid must be the type recommended by the manufacturer of the vehicle.

This warranty does not cover:

- a) The purchaser's loss of time, inconvenience, loss of use of the vehicle, towing expense, installation expense, commercial loss, or consequential damages.
- b) Fluids, gaskets, seals, filters, intake manifolds, clutches, water pumps, wiring, thermostats, sensors, hoses, belts, frost plugs, spark plugs, injectors, timing belts, and other materials or parts used in the installation of the purchaser's part.
- c) Claims that result from accident, abuse, neglect, alteration, improper maintenance, or improper installation.
- d) Claims that result from the failure of other existing components.
- e) Claims that result from overheating due to cooling system failure.
- f) Parts installed in vehicles used for commercial, racing, marine, off-road purposes, or parts used for other than original application.

Engines: Engine assemblies are understood to consist of a short block assembly and cylinder head (s) only. Any other parts left on the engine assembly at the time of sale are included for possible purchaser convenience only and are to be used at the purchaser's option only. These parts are not covered under the warranty. Engine will have a heat tab placed on it.

Short block: is an automotive term describing an engine sub-assembly. A short block is the portion of the engine block below the head gasket but above the oil pan. An in-block cam engine will also include the camshaft and timing gear. The overhead cam style of engine will not include the aforementioned parts on the short block.

Body cuts: Body cuts including front end assemblies, quarter panels, roofs, center posts, rockers, rear clips, and box sides must have a cut sheet completed and signed by the customer at the time the order is placed. Body cuts are non-returnable and non-refundable. COD customers must pay in advance before cutting begins.

Returns: Should you need to return a part, call your sales representative for a Return Merchandise Authorization number. Parts must be returned in the same condition, complete, and undamaged. Special order parts are subject to freight charges and restocking fees. Exchange only on electrical and fuel only parts. No refund on unmarked parts, if our special marking is removed, all warranties are void and no replacement made. Melted heat tab voids all warranties and renders part non-refundable.

Payments on account are due the 30th of the month following invoice date.

Return freight on cores is the responsibility of the purchaser. Cores must be drained of all fluids and be complete as sold.
